JUNIOR MEMBERSHIP APPLICATION

Cypress Soaring, Inc. is a non-profit corporation organized for the purpose of promoting soaring. The club is based at Hemet Ryan Airport, Hemet, California.

The corporation currently has four sailplanes: a Krosno two place trainer, a Blanik L-33 single place sailplane, a PW-6 two place sailplane, and a Discus single place sailplane.

There are no **aircraft charges** for flight time. Members are responsible for the cost of the tow.

INSTRUCTION

Instruction is provided by several club instructors. One is usually scheduled for a Saturday or Sunday on weekends. Other instruction may sometimes be scheduled on an individual basis. There is no charge for instruction.

MEMBERSHIP

Junior Membership is available to full-time students between the ages of 14-22. Junior Members are limited to flying the Krosno trainer and the L-33 single-place sailplane. Junior Members must convert to full Active Membership upon reaching their 23rd birthday or if they wish to upgrade to Active 3 or above membership.

COSTS

The basic initiation fee is \$152. for Junior Membership. A prospective member is required to submit a check for \$152. with his/her application. Upon acceptance into the club, the check will be cashed and the new member will be permitted to fly the Krosno. An additional fee of \$50 for the privilege of flying the L-33 aircraft will be required when the member is qualified to fly, and desires to advance to that aircraft. Club members operating aircraft are **liable** for the first \$1500 damage to club equipment in the event of an accident or damage to equipment.
